WELCOME New MACT Student:

Welcome to your first course in the Mississippi Addiction Counselor Training (MACT) program. We are very pleased that you have chosen to join us for this important training program and hope that it is beneficial to you and your work in the addiction counseling field. In order to help you get off to a good start, we would like to offer you the following helpful information about the training:

Once you have enrolled, we presume that you will complete the year long training program, so you are automatically re-enrolled for the next course. Attached is a Tuition Agreement that explains the guidelines and requirements. Once you have read it carefully, we ask that you sign and return it to us no later than the first day of your first course.

ATTENDANCE

Each course consists of three weekend training sessions that are held once per month. The training curriculum has been designed to encourage full attendance. Students are encouraged to attend all the training sessions, to be prompt in attendance, and to avoid missing any sessions. All courses are comprehensive in nature and are divided into three (monthly) parts by the instructors for their specific training methods. For this reason, missed sessions **may not be made up**.

Accurate attendance records are maintained. Roll will be taken at 8:15am. Sign-out sheets will be provided for you to sign at the end of each session after the instructor releases you for the day. If you need to leave prior to the instructor releasing students for the day, you will need to sign out with the instructor. Failure to notify the administrator of your presence in class or sign-out will result in zero (0) hours for that day.

While we realize that students may miss some sessions due to a variety of important reasons, no "excused" absences are given for any reason. Training time is simply missed. If you are unable to attend a session, please give us a courtesy call. Students missing two consecutive training sessions without notifying the MAAP office will be automatically dropped from the roll and must re-register for future courses on a space-available basis.

CERTIFICATES

Contact hours for continuing education are earned for each course, which can be applied toward certification requirements. Each student receives a mini-certificate at the end of each course quarter indicating the number of contact hours earned. The information for these certificates comes from the sign in/out sheets. Those who complete the year-long program are awarded a graduation certificate at the end of their last class with the full number of hours completed. TUITION AGREEMENT

It is agreed that MAAP shall:

1. Provide 186 hours of instruction on the basics of addiction counseling over a period of one year.

2. Notify student as far in advance as possible of any necessary changes in the training schedule because of unforeseen circumstances. Training schedule is located on our website under MACT at www.msaap.net .
3. Provide highly qualified instructors in the field of addiction studies who meet the following criteria:
 - a. Proven current experience in the addictions field;
 - b. Demonstrated mastery of field of expertise; and
 - c. Exceptional skills in verbal communications and design of training.
4. Hold confidential all personal information provided by student. Keep accurate records of student hours. Maintain website calendar.

It is agreed that Student shall:

Tuition Fees: Student may pay tuition in either of the following increments (CHOOSE ONE):

_____ \$350 per Course (Members); \$395 (Non-Members), due 10 days prior to the course start date. Pay an additional sum of \$75 (Members); \$100 (Non-Members), for Ethical Issues in Addiction Counseling no later than 10 days prior to the Ethics class for those paying by the course.

_____ \$775 (Members) \$890 (Non-Members) per half year, due at time of registration and 10 days prior to the third course start date (includes Ethics).

_____ \$1,475 (Members) \$1,680 (Non-Member) payment in full, due at time of registration (includes Ethics).

2. Failure to keep accounts current may result in termination from the program.
3. Absence from class does not absolve students from making payments. Students must pay full course fees even if unable to attend all class sessions.
4. **REFUND POLICY:** Upon written notice from student no later than two weeks prior to the start of the pre-paid course; fees will be refunded in full. Registration fees and membership dues are non-refundable.
5. Once you have enrolled, we presume that you will complete the year long training program, so you are automatically re-enrolled for the next course. Once you have read this tuition agreement carefully, we ask that you complete, sign and return it to us with your first course payment.
**We would also like to mention that if your goal is to obtain certification with us, that one requirement of Certification is membership. Membership is on an annual basis (January) and is prorated throughout. This will save on additional costs for trainings, etc.

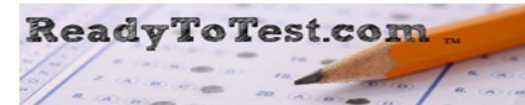

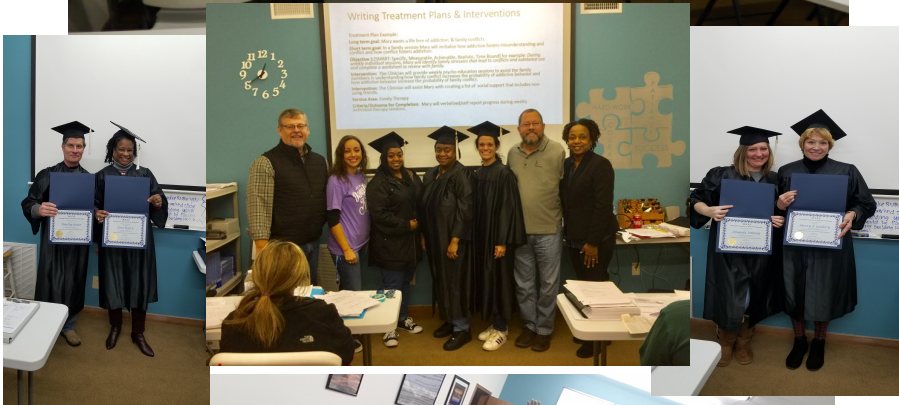

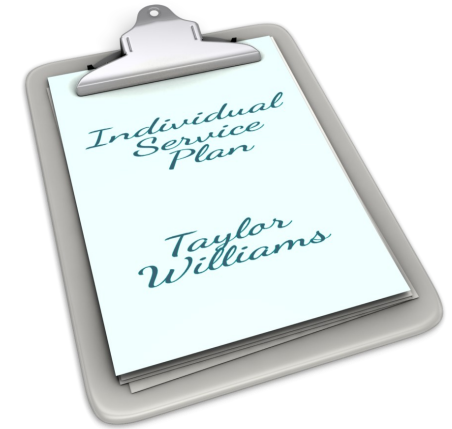

In order to effectively carry out its mission, MAAP depends on the generosity of its volunteer members to serve on the Board of Directors of the association, Certification Board and various standing committees.

Are you interested in becoming certified?

Certification for addiction professionals is designed to accommodate and evaluate those who are experientially trained as well as those who are academically trained. The certification process defines the core knowledge and skill base needed by all professionals regardless of their professional training, orientation or occupation. The certification process sets a baseline standard for professionals providing services to individuals with alcohol and drug abuse problems. Such professionals are given recognition for meeting specific predetermined criteria. The purpose is to assure that quality treatment services are available to individuals with substance abuse problems. Certification provides a professional credential that can assist employers in selecting competent staff to work with this populations.

Where do I begin?

Begin by looking over the Credentialing pages on our website. Which type and level of certification are you most interested in pursuing? Once that is determined, do you meet, or are you close to meeting, the qualifications to submit an application packet and portfolio to the Certification Board? If so, download and print the Certification Manual, Application Packet & Portfolio for the credential you are seeking. If not, consult with your supervisor (s) for assistance in obtaining the appropriate certification for your career goals. You may need to further your education or obtain additional work experience to meet the guidelines. Whatever it takes, don't give up!

CERTIFIED INTERN COUNSELOR

Education

192 hours of education/training specific to the domains. Six hours must in Ethics to include specifics relating to alcohol & drug counseling and six hours must be specific to HIV/AIDS training (MAAP Ethics class is mandatory for those applying for ANY of the MAAP Addiction Credentials).

Code of Ethics

Applicants must sign a code of ethics statement to include specifics relating to alcohol & drug counseling.

Renewal

20 hours of continuing education/training earned every two years, which must include topics relating to the IC&RC ADC domains, and must include 2 hours in Ethics to include specifics relating to alcohol and drug counseling and 2 hours in Person Centered training. This is a four year credential and you must have the remainder of your ADC portfolio ready in this time. Visit our website for ALL requirements.

PURPOSE

The Mississippi Addiction Counselor Training (MACT) Program exists to help behavioral health students and professionals improve their skills to better serve persons addicted to harmful chemicals. All course work is structured in a manner to encourage both personal growth and professional development.

The program is designed for both experienced counselors looking to upgrade their skills, intern counselors working toward a credential, and individuals who are seeking employment in the addiction counseling profession. All training is provided in a safe learning environment conducive to personal and professional training and growth.

Eligibility

MACT courses are open to all individuals interested in learning more about chemical dependency. Many students have an interest in becoming a professional addiction counselor in a variety of social or work settings. Allied health professionals such as social workers, nurses, marriage and family therapists often benefit substantially from developing specialized addiction skills to better assist the individuals with whom they serve. A commitment to become a full-time counselor is not necessary for course enrollment. However, a strong desire to study the chemical dependency field is essential. A college degree is not required, but students are required to have a minimum of a high school diploma or GED.

Approved Provider

All MACT course offerings are approved by the Certification Board of the Mississippi Association of Addiction Professionals for credits toward certification and recertification as an addictions counselor in Mississippi. Other official professional continuing education accreditation groups, may also recognize MACT course work for continuing education credits.

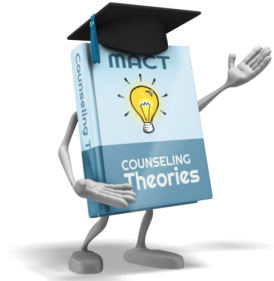
Core Courses

Goal: To familiarize the student with the basic pharmacological properties, effects, and consequences of alcohol and drug abuse in our society.



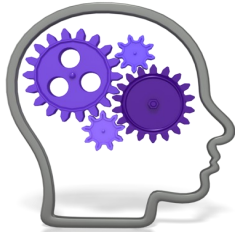
Counseling Theories (Jun, Jul, Aug)

Core Courses

The MACT Program offers a series of four (4) “Core Courses” that provide students a comprehensive survey of information essential for developing basic addictions counseling skills. These courses are fully described below. Class sessions meet Saturdays & Sundays on a monthly basis for twelve (12) months. Classes meet from 8:00 a.m.–5:00 p.m. on Saturdays, and 8:00 a.m.–5:00 p.m. on Sundays. Students may begin the class sessions in March, June, September, or December, and are encouraged to enroll for the full year’s training in order to fully benefit from the course work. The four Core Courses total 180 hours of contact hours, which may be applied toward certification.

Ethical Issues in Addiction Counseling

This Ethics training class is mandatory for those applying for ANY of the MAAP Addiction Counselor Credentials.

This Training class explores essential ethical issues in addiction counseling. This workshop has been moved to online, (via ZOOM), starting August 20, 2022. This workshop is open to anyone interested in the subject. Pre-registration is required and is accepted on a first-come-first serve basis. To pre-register, simply e-mail the completed registration form with the appropriate fees. All registrations are confirmed by email.

Tuition and Fees

Registration is accepted on a first-come-first-serve basis and space is limited. To register, simply email the completed registration form with the appropriate registration fee and course tuition. Registration fees are non-refundable, but tuition fees are fully refundable up to two weeks prior to the start of a Core Course upon written request. All registrations are confirmed by return e-mail.
